1 EXECUTIVE SUMMARY

The National Focal Point (NFP) submits its second Strategic Report of the EEA and Norwegian Financial Mechanisms 2014-2021 to the Financial Mechanism Committee and to the Norwegian Ministry of Foreign Affairs, in accordance with the Article 2.6 of the Regulations on the implementation of the EEA and Norwegian Financial Mechanisms 2014-2021.

Preparation of programmes is completed and the implementation is about to start.

Following the drafting and submission of the Programme Concept Notes (CN) during first half of 2018 the Programme Operators (POs) continued with the preparation of the supplementary information that needed to be submitted to the Financial Mechanism Office and to the Donors for the preparation of the Programme Agreements. By the cut-off date of this Strategic Report all nine programmes have been officially approved by the Donors and for eight of them the Programme Agreements have been signed as well (the only exception is the CZ-GOVERNANCE programme where the Programme Agreement is to be signed during September 2019).

Hand in hand with the approval of the programmes the Programme Operators started to draft the description of the Management and Control Systems at the level of POs and gradually submitted them to the NFP for approval within the deadlines set by the Regulation.

Currently the open calls and/or calls under small grant schemes are under preparation and most of the calls shall be launched by the end of 2019 or early 2020. The exception is CZ-EDUCATION where first calls were launched at the end of 2018 or in the 1st half of 2019, and 2nd round of calls for all 4 outcomes is planned to be launched in autumn 2019. Most PDPs promoters were asked to submit project applications for consultation with the POs before asking the PDPs promoters for the official submission. No major problems within programmes are reported so far, although the start of the implementation is a bit delayed as the process of Programme Agreements signatures was in most cases longer than expected.

The Joint Committee for the Bilateral Funds (JCBF) established in 2017 is fully operational and actively involved in implementation of Bilateral Funds. The 2nd JCBF meeting was held in April 2019 in order to assess the results and experience from the 1st Open Call, to agree on modifications for the 2nd Open Call (subsequently launched in June 2019) and to update the Work Plan. The Expression of Interest for additional bilateral funds for CZ-CULTURE programme was approved as well.

The bilateral ambitions within the programmes are being enhanced via open calls for bilateral initiatives and specific activities organized by the POs. These are targeted mainly on networking, match-making, information activities prior to the launch of calls, exchange of know-how in areas of mutual interest, and, last but not least, preparation of strategic projects in partnership with the donor state entities.

The implementation of the Fund for Bilateral relations is considered very effective.

The amount disbursed within the programmes by 30 June 2019 and certified by the CA by 15 September 2019 (excluding CZ-GOVERNANCE not being certified yet) equals 1,73 mil. EUR (ca 0,99 % of the total allocation including PRG co-fi). The amount of incurred expenditures is proportionate to the status of the programme implementation.

In the publicity and promotion the National Focal Point focus mainly on the activities in order to increase awareness of general public on the EEA and Norway Grants and to promote interesting projects from past two periods at the opportunity of 15 years Anniversary of EEA and Norway Grants in the Czech Republic.

2 POLITICAL, ECONOMIC AND SOCIAL CONTEXT

Since the signature of the Memoranda of Understanding there were no significant changes in political, economic and social area that had or could have an impact on the implementation of the Financial Mechanisms.

The economy of the Czech Republic grows, although the high level of growth from the last years is gradually slowing down. The growth is driven mainly by the household expenditure for final consumption (mainly investments to housing) caused by the increase in salaries and significant increase of pensions. Also the investments of government institutions played the significant role for the growth. On the other hand the growth is slowed down mainly by the lack of employees and demand for qualified industrial professions. The unemployment rate in the Czech Republic is one of the lowest in the EU and could only increase. This situation on the labour market causes the increase of salaries and wages as well as demand for investments into innovations to increase the labour productivity. Hand in hand with the increase of household incomes is the inflation rate that is on the upper edge of the tolerated level, the most significant was the increase of costs of housing and energies. To conclude, the economic situation in the Czech Republic more or less copies the situation in the whole Europe.

As concerns the social area as well as civil society sector the underfinancing still continues. From that reason any grant schemes allocated to this area are highly welcomed. Particularly non-governmental organizations who quite often substitute the role of the state in some parts of social area welcome the launch of open calls or small grant schemes in all possible programme areas financed by the Financial Mechanisms.

In the political development in the Czech Republic the municipal elections were held in Autumn 2018 (with no impact on the EEA and Norway Grants).

3 EFFECTS OF THE GRANTS

The EEA and Norway Grants 2014-2021 in the Czech Republic are only in their early stage. Although almost all of the Programme Agreements have been signed, any results of the Grants cannot be measured yet.

No call has been launched so far except the calls within the programme CZ-EDUCATION where the projects mainly intended to start with the coming school year 2019-2020. Similarly, the pre-defined projects are before approval, some to be launched starting late 2019.

However, a significant progress has been made within implementation of bilateral cooperation within the Fund for Bilateral relations. Up to now, the Fund has offered grants via 2 open calls and pre-defined initiatives at national level. Thanks to the bilateral funds, several new partnerships/relations were established and developed between Czech schools, NGOs, research institutions and private subjects and donor states entities, several of them with the aim to continue with preparation of joint applications for grants in particular Programmes. At programme level, the bilateral funds were utilized by POs mainly for preparatory measures / visits as the open calls are in preparation.

<p>the programme</p>	<p>partners through match-making (very important in the cultural heritage area) and with direct support for bilateral meetings (4 bilateral calls) enabling to establish the partnership (more suitable for the area of contemporary art).</p> <p>In total, the activities in 2019 have reached out to approximately 100 cultural operators from donor states and almost 90 cultural operators from the Czech Republic so far.</p> <p>We see high interest in profound bilateral cooperation in the area of cultural heritage. This is probably caused by the revitalization aspect of the projects and rich experience on the side of the donor countries. In this area, it proved very efficient to facilitate first introductions (e.g. Industrial Study Trip in Norway with match-making opportunities in 11/2018) and to support bilateral meetings to follow up and establish the partnership cooperation. Some of the donor state partners involved in bilateral activities seem to be interested in cooperation with more than one applicant. This seems very practical considering the lower success rate and other practical reasons such as shared travels, same rules and guideline compared to an involvement in more beneficiary states. As a side effect, this can inter connect Czech entities with similar needs and facilitate exchange of know-how.</p> <p>In 2019 we have organized two meetings of the Cooperation Committee so far. The first was hosted by the Norwegian Directorate for Cultural Heritage in Oslo on 13.2.2019 and the second was hosted by the Icelandic Centre for Research in Reykjavík on 13-14.6.2019. Another meeting is expected after the announcement of the main open calls in 4Q 2019.</p>

4.1 Disbursements and financial reporting on programmes

During the first two certifications the CA struggled with the set-up of IFRs in GRACE. Firstly, the rounding method in GRACE is not set correctly and as a consequence, the amounts of allocations, actually incurred and proposed expenditure are not calculated correctly. This results in inconsistencies between the information system of the CA - VIOLA and IS GRACE. Secondly, the structure of downloaded versions of IFRs is not very well arranged. Especially, absence of amounts of proposed and expected expenditure filled in by the PO in part B makes the calculation less transparent.

In August 2019 the CA was engaged in certifications of 11 programmes in which the programme agreements were signed by 15 July 2019. As a result, the amount certified by the CA by 15 September 2019 equals 1 728 267 EUR (ca 0,99 % of the total allocation including PRG co-fi) and includes expenditure incurred by POs until 30 June 2019 within 11 programmes (excluding CZ-GOVERNANCE not being certified by 15 September 2019). Within the reported expenditure there are mostly programme management costs incurred for preparation of programmes such as salaries, travel costs, translations, catering and publicity. Within the CZ-BF programme expenditure incurred on bilateral activities were reported (bilateral meetings organized by POs/POs taking part - catering, travel costs, translations; payments to pre-defined initiatives at programme level; payments within the open call and to pre-defined initiatives at national level).

By 30 June 2019 the amount of 2 640 909 EUR (ca 1,76 % of the total allocation, PRG co-fi excluded) was disbursed by the FMO to the CA source account. The payments were made based on the first IFRs in programmes CZ-TA, CZ-BF and CZ-EDUCATION submitted to the FMO in April 2019. The amount also includes advance payments to programmes CZ-TA and CZ-BF.

Due to national specifics in financial flows in case of some programmes having their expenditure pre-financed from the state budget the CA keeps the funds received from the FMO on their source account and only makes reimbursements of actually incurred expenditure certified in IFRs (CZ-TA, CZ-RESEARCH, CZ-ENVIRONMENT, CZ-HOMEAFFAIRS, CZ-EDUCATION, partly CZ-BF). To the rest of programmes the CA makes disbursements of proposed expenditure immediately after their receipt from the FMO in compliance with the Regulations. In addition, the CA can make payments to project promoters which are Organizational Units of the State/State Contributory Organizations and to final beneficiaries of initiatives within the CZ-BF national level. As a result of the specifics stated above, up to 30 June 2019 the amount of 667 158 EUR (ca 0,44 % of the total allocation, PRG co-fi excluded) was paid by the CA to POs/CZ-BF final beneficiaries.

5 STATUS OF BILATERAL FUNDS

The Joint Committee for the Bilateral Funds (JCBF) established in 2017 has been fully operational and actively involved in BF implementation.

Within the **1st Open Call** 17 bilateral initiatives were supported and the allocated amount of 250 000 EUR was fully committed within 5 months (August 2018 to January 2019). 12 approved initiatives have been realized in partnership with Norway, 2 with Iceland, 3 with more donor states. As for the supported areas of mutual interest, these were mostly culture (7) and children or sport (6), the other focus was on research (3) or smart cities (1). Most grants (10) were awarded to the NGOs, 3 to universities, 3 to private companies and 1 to a state contributory organisation. The supported initiatives are in an advanced stage of implementation, some of them have already been completed. From the 250 000 EUR allocated 138 683 EUR have been reimbursed by August 2019. According to the information provided by final beneficiaries in the monitoring reports, financial contribution provided within the BF is highly appreciated, bilateral relations were significantly strengthened and the mutual cooperation confirmed the expected potential for future projects.

The **2nd JCBF meeting** was held via a videoconference on 1 April 2019. The assessment of the 1st Open Call and proposals for modification within the 2nd Open Call were the key issues of the meeting. All JCBF members expressed their positive feedback on effective procedures, significant applicants' interest and surprisingly fast commitment of the first open call's allocation. Moreover, it was mentioned that the Czech approach and procedures are shared as best practice with the other Beneficiary States.

The JCBF also negotiated the submitted **Expression of interest** for increase of bilateral funds within the CZ-Culture programme. The members agreed on the approval after additional correspondence and adjustments in late April 2019. The allocation of funds to CZ-Culture was increased by 87 500 EUR with respect to more projects expected and to the overall complexity of the programme which had been presumed even in the Concept Note. The JCBF approved also adjustments in the 2nd Call planned for May/June 2019.

The JCBF **Work Plan** was updated in terms of the 2nd JCBF meeting conclusions and adopted via written procedure in May 2019.

The **2nd Open Call** with the allocation of 300 000 EUR has been launched in June 2019. The JCBF agreed to limit the eligibility of the Donor states' entities to Norway only in the 2nd Open Call. Several

adjustments in the Call text as well as in rules had been done to reflect experience and best practice from the 1st Call, especially the evidence of expenditures was simplified and the maximum grant amount was reduced from 50 000 EUR to 20 000 EUR, in line with the 2nd JCBF meeting conclusion. The evaluation of applications is on-going – by the end of August, 32 applications were submitted and 11 initiatives were approved in total amount over 155 000 EUR. Disbursement of advance payments to approved initiatives is being provided since August 2019.

In line with the Work Plan, the **3rd Open Call** shall be announced in 2020. The timing will depend on the commitment of the 2nd Open Call.

Two **pre-defined initiatives** planned for 2018 have been successfully finished, one reimbursed. The regular school exchange between Liechtenstein and the CR shall continue in 2019, a joint grant application for financing of the schools' activities (second round) has been submitted and approved in August 2019. Similarly, the work of Czech-Liechtenstein Commission of Historians continues in 2019, the grant application in partnership with the Historic Association of Liechtenstein has been submitted. As for 2019/2020, two new pre-defined initiatives for cooperation with Iceland aimed at a) exchange of good practices in the implementation of modern technologies and b) cooperation of experts in the field of gender pay gap were confirmed by the JCBF, were included into the Work Plan and are in preparation.

At **programme level**, the bilateral ambitions are being enhanced via open calls for bilateral initiatives within respective programmes (CZ-Health, CZ-Culture and CZ-Environment) and specific activities organized by the POs. These are targeted mainly at networking, match-making, information activities prior to the launch of Open Calls for project proposals, exchange of know-how in areas of mutual interest, and, last but not least, preparation of strategic projects in partnership with the donor state entities.

Match-making seminars aimed at establishing and development of contacts, partnerships and effort for joint applications in future Open Calls for project proposals have been organized in the programmes CZ-Health (in January 2019), CZ-Environment (in April 2019) and CZ-Culture (in May 2019). Mutual visits of PO and the DPP in order to establish working contacts and to agree upon strategies for future implementation took place in CZ-Research (with RCN in Oslo, to network with RANNIS in Reykjavik) and also in programmes within pre-defined projects such as CZ-Health (3 pre-defined bilateral study trips), CZ-Justice (2 study visits), CZ-Human Rights (4 visits and 1 joint attendance of an international event).

In the near future, the call for preparatory visits will be launched in CZ-Education (September 2019). The CZ-Research programme is designed without any Open Call for bilateral initiatives so the PO shall encourage applicants to utilize PO's joint match-making events or to apply in the NFP open calls for bilateral initiatives.

The programmes composed of PDPs shall continue in bilateral activities via pre-defined initiatives within the particular PDP, such as mutual visits and meetings and working sessions, round tables etc.

So far, **the NFP itself** has not implemented any bilateral initiative. In addition, no activities are planned in the following 12 months.

The overall balance of the bilateral funds is quite proportionate, relevant to the very start of the programming period. From the allocation of 3 690 000 EUR the amount of 285 183 EUR has been spent (by 30/6/2019, IFR2).

In the upcoming year utilization of bilateral funds is expected in the larger extent than in 2019, because the launch of Open Calls for project proposals in programmes shall require effective support for operative networking, meetings and joint events for applicants. Also the planned and approved pre-defined initiatives shall strengthen the bilateral cooperation.

The text of this chapter was consulted and agreed on by the JCBF via written procedure and it was also agreed by the JCBF that there is currently no need to organize the third JCBF meeting in 2019.

6 MANAGEMENT AND IMPLEMENTATION

6.1 Management and Control Systems (MCS)

The **national level Management and Control System (MCS)** was officially acknowledged by the donors in December 2018 after incorporation of specific conditions of the donors related to separation of functions between the PO and the NFP placed at the Ministry of Finance. Other specific and pre-payment conditions related to the separation of functions were set in the relevant Programme Agreements and are followed by the NFP.

The **Methodology of Financial Flows, Control and Certification of Programmes financed from the EEA and Norwegian Financial Mechanisms 2014–2021** (hereinafter the “Methodology”), a key document setting up financial flows, investigation of irregularities, certification procedures and controls of the FM 2014-2021 in the Czech Republic, was approved by the Government of the CR and issued in November 2018. The English version of the Methodology was submitted to the FMO for information in March 2019.

During 2019, the NFP has issued more detailed written guidelines – the Guideline for Eligible Expenditures, Small-scale Public Procurement Guidance and Guidelines for POs. The documents are based on the procedures used for implementation of FM 2009-2014; however when updating the documents in line with requirements set in the Regulations for FM 2014-2021, the emphasis was placed on simplification and better clarification of rules and reduction of all unnecessary additional requirements.

No changes to the MCS and other documents have been carried out and no changes are expected in the near future.

The staffing of the national authorities is stable; there was only one more significant personal change at the position of the Certifying Authority (CA) Head of Unit (unit 5505, the National Fund Department of the Ministry of Finance). Mr. Petr Vránek left the position of the Head of Unit and the position is now represented by Mr. Josef Kurtiš, an experienced employee of the National Fund Department of the Ministry of Finance.

The descriptions of **MCS at the level of POs (PO MCS)** have been drafted and gradually submitted to the NFP for approval within the deadlines set by the Regulation.

The **PO MCS of the Centre for International Cooperation in Education (DZS)** managing the **CZ-EDUCATION** programme was submitted to the NFP in May 2019. The quality of the document was very high and after incorporation of the NFP comments and preliminary approval, the document was submitted to the Audit Authority (AA) in July 2019. The AA assessed the compliance of the MCS with the Regulation and generally accepted accounting principles. The AA issued an audit report pointing out several findings on which the audited entity (DZS) took corrective action plan. The findings in the report did not have negative impact on the positive opinion on the PO MCS. The NFP informed the FMO about approval of the PO MCS in August and September 2019 respectively.

The **PO MCS for programmes managed by the Ministry of Finance, i.e. CZ-CULTURE, CZ-HEALTH, CZ-GOVERNANCE, CZ-HUMAN RIGHTS and CZ-JUSTICE**, was drafted as one document. After settlement of the NFP comments the PO MCS was submitted to the AA in July 2019. It is expected that the audit report

and opinion of the AA will be issued by the end of September 2019. The PO MCS accompanied with the audit report and the opinion will be then submitted to the FMO in line with pre-payment condition set out in the respective Programme Agreements.

The draft versions **PO MCS** for programmes managed by the **Ministry of Interior (CZ-HOME AFFAIRS)** and the **State Environmental Fund (CZ-ENVIRONMENT)** have already been submitted to the NFP. With regard to less experience of the two new POs with particularities of the FMs and in order to ensure relevant quality of the documents, the NFP has been providing continuous assistance to the POs in drafting of the documents including meetings to clarify open issues and NFP's comments. It is assumed that both documents will be finalised and submitted to the AA in 4Q/2019.

The deadline for submission of **PO MCS for CZ-RESEARCH** programme managed by the **Technology Agency** is December 2019; however the PO plans to submit the first version of the document to the NFP earlier.

A change of the Annex B of the Memoranda of Understanding on the implementation of the EEA Financial Mechanism 2014-2021 and the Norwegian Financial Mechanism 2014-2021 was implemented. It related to the change of the PO of the CZ-RESEARCH programme. Originally, the Ministry of Finance was designated as the PO for CZ-RESEARCH in the MoU where was stated that the Technology Agency (TAČR) shall "be actively involved in and effectively contributing to the development and implementation of the programme". Taking into account the specifics of the CZ-RESEARCH programme, competences and experience in the area of applied research and in order to simplify the administrative procedures and financial flows it was agreed with the FMO and the Donors that the TAČR will officially take over the responsibilities of the PO. The change of Annex B of the MoUs was completed on 30 October 2018 and from this date it is valid.

6.2 Complaints

Although the complaint mechanism for EEA and Norway Grants 2014-2021 is established and procedures how to submit complaints are visible on the NFP website www.eegrants.cz and www.norwaygrants.cz, no complaints have been submitted so far.

This is because the EEA and Norway Grants 2014-2021 in the Czech Republic are only in their early stage, almost all of the Programme Agreements have been signed, but no call has been launched so far.

6.3 Irregularities

The first irregularities were discovered during certification of September 2019 IFRs. Actual irregularities were discovered in programmes CZ-BF (CZ-RESEARCH part), CZ-HEALTH (programme management) and CZ-JUSTICE (programme management). The irregularity cases will be reported to the FMO in November 2019 for the period July – September 2019. The irregularities were discovered before submission of September IFRs to the FMO and therefore, the respective expenditure will not enter the IFRs and will not be reported to the FMO as actually incurred.

6.4 Audit

With regard to current status of programmes implementation, the Audit Authority carried out neither audits assessing the functioning of the management and control system, nor audits of operations.

The AA has carried out an audit assessing the MCS of the CZ-EDUCATION Programme Operator with no major findings. An audit assessing the MCS of the CZ-HEALTH, CZ-JUSTICE, CZ-CULTURE, CZ-HUMANRIGHTS, CZ-GOVERNANCE Programme Operator is ongoing. Details about audits of PO MCS are included in the chapter 6.1.

7 COMMUNICATION

The Communication Strategy has been approved on 16 November 2018. As the main goal of the Communication Strategy is to increase awareness of general public on the EEA and Norway Grants, the most of activities made in past months were/are focused mainly on general public.

The overview of promotional activities made in September 2018 – August 2019:

- **Launch Event of the EEA and Norway Grants 2014-2021** where the programmes were presented took place in Planetarium Prague on 20 February 2019. The Czech Republic was represented by Ms Lenka Dupáková, Deputy Minister of Finance of the Czech Republic. The donor states were represented by H. E. Robert Kvile, the Norwegian Ambassador to the Czech Republic, H.E. Thórir Ibsen, the Ambassador of Iceland and Mr Dominik Marxer, Deputy Head of Mission at the Embassy of Liechtenstein to the Czech Republic. In total almost 80 participants (NFP, POs, programme partners, DPPs, FMO) attended the event.
- **Participation in the “Day of Europe 2019”** in Prague on 9 May 2019, where the stand was prepared in cooperation with the Royal Norwegian Embassy in Prague and the EEA and Norway Grants were presented to general public. It was a second participation of the EEA and Norway Grants at this event.
- As a very good opportunity to approach the general public the **NFP participated in popular 4-day musical festival “Colours of Ostrava 2019”** from 19 to 22 July 2019 as in the last year. The presentation of EEA and Norway Grants in the Czech Republic was organized together with the Royal Norwegian Embassy in Prague and the State Environmental Fund of the Czech Republic (PO for CZ-ENVIRONMENT). The main message was “15 years of the EEA and Norway Grants in the Czech Republic”. Competitions, workshops and activities aimed at ecology, environment and also research were prepared for public. Publicity was ensured by advertisement in festival bulletin, websites and Facebook.
- **Two promotional videos** of EEA and Norway Grants 2014-2021 (in Czech and English) were prepared by the NFP. The first one is animated video explaining meaning of the EEA and Norway Grants and their particular programmes. The second video is promoting the search for partners for bilateral cooperation through partner database. The videos are shared on the Facebook, YouTube and the NFP website.
- **Informational leaflet** promoting the new period of the EEA and Norway Grants 2014-2021 was created and distributed mainly during the “Day of Europe 2019”, “Colours of Ostrava 2019” and further events.
- **Promotional materials**, such as notebooks, pens, pencils, stickers, bags, balloons, menthols, lamps, spinners, etc. for usage at the promo events were created and delivered to the NFP.

- The **article promoting the launch of the 2nd open call within the Fund for bilateral relations** was published in national wide newspapers (Lidové noviny) on 26 June 2019.
- **Interviews with chosen project promoters** (from previous funding periods) to give examples of good practice were made in August 2019 and will continue till October 2019. Aim of this activity is to promote interesting projects from past two periods of the EEA and Norway grants at the opportunity of 15 years Anniversary. Articles and pictures regarding projects will be published at the website and social media.
- The **website** is continuously updated to be more user friendly and to provide relevant and actual information. The new section to assist to find a project partner including partner database was created.
- The NFP regularly uses **social media** such as Facebook, Twitter, Instagram and YouTube.
- The NFP participates at the activity of the Royal Norwegian Embassy in Prague – **competition “Grants in Movie”** for high school and universities. The aim is to promote best supported projects from last two periods in a short videos shared at the social media. The competition is under preparation and will be launched on 9 September 2019. Winner will be announced at the end of November 2019.

In the next months the NFP will continue in a communication activities aimed at general public to increase awareness of the EEA and Norway Grants and in cooperation with the Royal Norwegian Embassy in Prague. The NFP will also cooperate with Programme operators in promotion of the programmes open calls. The NFP will focus mainly on promoting results of bilateral initiatives that are already under implementation and will also prepare the article regarding the 15 years anniversary of EEA and Norway Grants in the Czech Republic and promoting the launch of the open calls within all programmes.

8 MONITORING AND EVALUATION

8.1 Monitoring

Besides informal monitoring activities based on a day-to-day contact with POs, the formalised monitoring activities carried out by the NFP-CFA2 can be divided into three main areas:

1) Monitoring of bilateral fund activities – Bilateral fund on the national level managed by NFP and Bilateral ambitions managed by respective POs – both through monitoring reports and on-the-spot check (not carried out so far due to short implementation period).

On the national level the monitoring of individual bilateral initiatives (both pre-defined and open call) runs through interim and final monitoring reports via electronic system CEDR.

Concerning the Bilateral ambitions managed by the POs – monitoring of the use of funds is carried out bi-annually on the basis of the written monitoring reports. Respective data and information is then used for preparation of the Interim Financial Reports (IFR) for CZ-BF.

2) Steering Committees and Cooperation Committees

NFP-CFA2 sets the so called Steering committees (SC) for each programme so as to regularly monitor the activities of the PO. The aim of the SC is to exchange information on current programme implementation development and to discuss possible difficulties and concerns of all involved stakeholders, NFP, PO and Programme partners. The first SC was organized in June 2019 for CZ-EDUCATION, for the rest of programmes the SCs are planned by the end of 2019.

NFP also regularly takes part in Cooperation Committees managed by PO as an observer.

3) Monitoring via external assistance

In line with the condition stated in PAs of the CZ-CULTURE, CZ-HEALTH, CZ- GOVERNANCE, CZ-HUMANRIGHTS and CZ-JUSTICE programmes, the NFP responsibilities regarding continuous structured risk assessment described in Article 5.3.3 of the Regulation, and the regular monitoring of the Programmes described in Article 5.3.4 of the Regulation shall be externalised and be carried out by a legal entity independent of and unrelated to the NFP. NFP plans to launch a public tender for the provider of the above mentioned service during September 2019. Subsequently the contract could be signed in October/November 2019.

There are three main areas of the public tender covering among other requirements stemming from the above mentioned condition:

a) Development of methodology for monitoring and programme risk management:

In cooperation with the external independent company, the NFP will develop methodology focused on FM3 programme monitoring and risk management in order to guarantee both the internal and external independence of the NFP as well as objectivity, impartiality and equal treatment of individual POs in accordance with MoUs, Regulations and PAs.

The output will be a written document that will be submitted to the FMO for review at the turn of 2019 – 2020.

b) Supervision of NFP's activities:

The external independent company will continuously monitor and verify compliance of NFP activities including monitoring described under points 1) and 2) above, risk management, adherence to methodologies and adherence to request for the separation of functions among NFP and PO placed at the Ministry of Finance.

The output will be a report on NFP activities drafted by the external company, created on an annual basis and including a summary to be added to the Strategic report. The report will provide information on compliance of the NFP with conditions related to separation of functions. The supervision shall be provided in the period 2020 – 2025.

c) Verification of programmes' implementation (on-the-spot):

The external independent company will carry out on-the-spot verification of programme implementation, which shall cover all PO activities related to fulfilment of the programme objectives, obligations set in the PIA, other contracts and guidelines and methodologies issued by NFP, CA or FMO. The on-the-spot checks will also include identification of risks in the programme and their solution and the possible changes in the programme.

The output will be a report including a check-list from each on-the-spot verification. Altogether 11 verifications (9 – for each programme, 2 – optional as needed) are planned during the period 2020 - 2023.

8.2 Evaluation

The evaluation plan annexed to this Strategic Report shall be understood as a preliminary portfolio of evaluations to be commissioned by the NFP. While the plan respects the structure of the mandatory template and the requirement of Regulations to evaluate each programme at least once, the NFP's ambition for the current programming period is to focus more on thematic (rather than programme) evaluations and to gain maximum formative evaluation findings and recommendations so as to be able to improve the performance or design of programmes where possible.

The evaluation plan will be further developed with the POs and PPs/DPPs. Key aspects such as timing of the evaluation with respect to programme developments or its main purpose (evaluation questions) shall be specified by the end of 2019, when the Terms of Reference will be prepared.

9 ISSUES FOR THE ANNUAL MEETING

As the Ministry of Finance acts as the National Focal Point and it is also the Programme Operator for 5 programmes (CZ-CULTURE, CZ-HEALTH, CZ-JUSTICE, CZ-GOVERNANCE and CZ-HUMAN RIGHTS), the separation of functions is ensured with the particular emphasis on the equal approach to both “internal” and “external” POs. The conditions connected with the separation of functions proposed by the Donors were accepted by the NFP as well as by the PO and following the discussion during the last Annual Meeting they were incorporated to the national level Management and Control System and are also stipulated as the conditions (general, pre-payment) in the Programme Agreements of the respective programmes. The Programme Operator respected these conditions also when preparing the PO MCS that needs to be submitted to the FMO (expected in October 2019). The NFP responsibilities regarding continuous structured risk assessment and the regular monitoring of the Programmes will be externalised and be carried out by a legal entity independent of and unrelated to the NFP as described in chapter 8.1.
