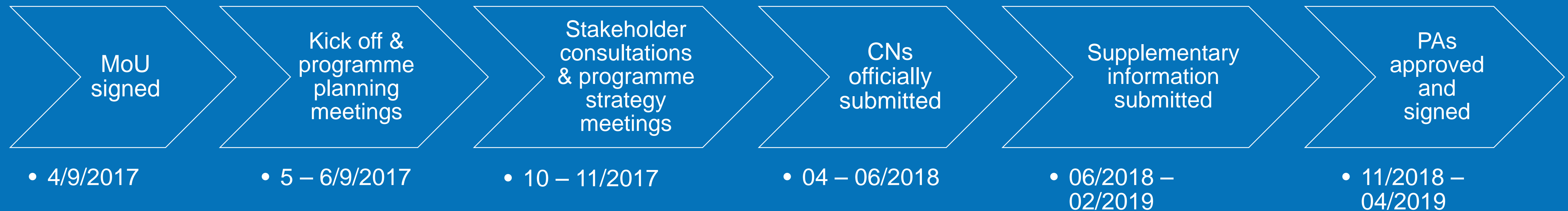

- **EEA and Norway Grants 2014 – 2021 - third period of Grants in the Czech Republic**
- **Memoranda of Understanding signed on 4 September 2017**
- **Allocation for the Czech Republic – 184,5 mil. EUR**
- **Implementation period up to April 2024**
